Subject: Disposal of deteriorated food grains lying in Gulab Bagh Central Godown and Ration Ghats of Srinagar district damaged during the flood fury in Kashmir Valley.

Whereas, during the recent floods, a number of CA&PD godowns and Sale Outlets got damaged in the Kashmir valley.

Whereas, a Committee of the following Officers was constituted by the Divisional Commissioner, Kashmir, Vide No. Div. Com/Relief Floods (2094)GO/014 dated 29-09-2014 read with corrigendum issued Vide No. Div.Com/Relief Floods(2094)GO/014 dated: 04-10-2014.

- ii.** Director Accounts & Treasuries, Kashmir (Member).
- iii.** Additional Deputy Commissioner, Srinagar (Member).

- vi.** Deputy Director, Sheep Husbandry Department, Kashmir (Member).

Whereas, the Committee has asked the CA&PD Department to furnish the collateral details from the records to confirm that the quantities available for verification on 04-1-2014 were genuine and substantiated by the records.

Whereas, the said Committee was of the opinion that the foodgrains under reference had remained in contact with the flood water for quite some time and its use for human consumption cannot be recommended especially in view of the advisories issued by the Health Department.

Whereas, 17787.44 Qtls of Rice and 23811.48 Qtls of Sugar got damaged due to flood fury in Srinagar district as certified by the Director CA&PD, Kashmir.

Whereas, on the basis of the recommendation of the Committee constituted by the Divisional Commissioner and on the basis of the certificate given by the Director CA&PD Department, Kashmir a memorandum was placed before the Cabinet for writing off value of 17787.44 Qtls of Rice and 23811.48 Qtls of Sugar amounting to the Rs.10.54 crores.

Whereas, the Cabinet Vide decision No. 178/12/2014 dated: 10-10-2014 has approved the proposal of CA&PD Department for writing off stocks damaged due to flood fury in the Srinagar district.

Now therefore, sanction is accorded to the Constitution of a disposal Committee comprising the following Officers for immediate disposal of deteriorated foodgrains lying in the Central godown of Gulab Bagh Srinagar and Other Sale Outlets in Srinagar district:-

The Committee shall dispose of the deteriorated foodgrains lying in the Gulab Bagh Central Godown and Other Sale Outlets of Srinagar district within a period of one week, subject to the following terms and conditions:-

1. Verification/Confirmation of quantities for ascertaining the authenticity of the verified stocks, the balance is confirmed by the Physical Verification Officer on the conduct of last physical verification to be treated as opening balance and daily receipts thereafter up to 05-09-2014 added to it and daily issues be deducted. The balance arrived at should reconcile with the balance projected for write off.
2. The Committee shall segregate the consumable rice and sugar, if lying in the godown during the flood fury.
3. The Committee shall dispose of the deteriorated foodgrains in presence of all the members of the Committee and the media.
4. The Directory CA&PD Department, Kashmir/Chairman of the Committee shall certified the availability of flood affected stock rice and sugar lying in the Central Godown of Gulab bagh and other sale outlets of Srinagar district on the prescribed format.
5. The entire operation of shifting and destroying of deteriorated stocks will be video-graphed.

6. After deteriorated stock is disposed of, the Director CA&PD, Kashmir shall furnish a certificate certifying therein that the stocks have been destroyed in presence of the aforesaid Committee, who will also sign and authenticate the same under their signatures.
7. The stocks to be disposed off shall be first got tested through public analyst to ascertain whether or not as on date the deteriorated foodgrains are fit for human and/or animal consumption.
