In pursuance of G.O No. 195-PD OF 2016 dated:-01-04-2016 issued by the Planning and Development Department under endorsement No. PD/2016-17/Coord-101/01-A dated:-01-04-2016, sanction is hereby accorded to the release of **Rs. 6.25 lacs (Rupees Six lac and Twenty five thousands only)** representing 25% of the Capex Budget 2015-16 in favour of Director CAPD Department Jammu for further placement at the disposal of Managing Director J&K Housing Board along with the **advance drawal** for "**Construction of Director CAPD Office Jammu**" for its utilization during the year 2016-17.

The release of funds shall be subject to the following terms and conditions:

1. All necessary Administrative Approvals and Technical Sanctions shall be obtained prior to the execution of works/projects. In case of cost revision, necessary revised Administrative Approval shall be obtained from the Competent Authority for incurring expenditure.
2. The expenditure shall be restricted to the administratively approved cost of the project /work only.
3. The funds released shall be utilized for the specified purpose only after strictly observing all codal formalities required under rules.
4. No diversion of funds is allowed.
5. The progress achieved under the Scheme both in terms of Physical/ financial shall be communicated to the Administrative Department by 1st of each month.


