The order of appointment shall be subject to cancellation ab-initio, in case, at any stage, it emerges that the certificates/documents furnished by the appointees are take/fictitious.

The salary of the appointee shall be drawn and disbursed only on receipt of a satisfactory report about the verification of the character antecedents from Inspector General of Police, CID to whom a reference shall be made by the concerned HOD.
